



A word about Sri Sumangala College

Panadura.



The people-loving illustrious citizens of Panadura, Mudaliyar Thomas Rodrigo, Mr.M.Maththes Salgado, Mr.P.C.H.Dias, Mr.M.Cornelis Perera, Mr.P.Luwis Dias and Mr.P.Dumingo Dias, thrilled by the Buddhist re-awakening brought about by Great Panadura Debate, inaugurated a Buddhist school to enable the Buddhist children of the Panadura area, on

March 3, 1909 in two small buildings at the Rankoth Vihara Premises, Panadura. The two children that were first admitted to this school were the two sons of one of these pioneering gentlemen, Mr.M Maththes Salgado, the two brothers Walter Salgado and Richard Salgado.

The first Principal of the school was Mr.Thomas E. Gunarathne and according to past students, the Principals that did yeoman service to the school were Mr.R.S.S.Gunawardena, Abeyseela Ginige, A.M.De Silva, M.W.Karunananda, P. De S. Kularatne, Dr. K.L.V.Alagiyawanna, Mr.H.S.Newton Fernando and Mr.D.E.Jayanethi. Mr. Abeysinghe Ginige pioneered in establishing the Sri Sumangala Old Boys' Association on October 28, 1992, a fact that should be mentioned with gratitude.

All classes except the Primary Section were established in Nalluruwa, Panadura, in 1942, and when the school was upgraded as a National School in 1991, the Primary Section was also moved to Nalluruwa. The school, which was devastated on December 26, 2004 in the tsunami, was planned to be constructed in Walawuwatte, Wekada due to a decision taken by the Government. JAICA organization of Japan, out of the sponsors put forward by the Government, came forward to supply monetary provisions to the value of 390 million Rupees. On November 15, 2005, the foundation stone was laid by the then Chief Minister of Western Province Reginold Cooray, inaugurating the construction work. Overcoming the obstacles placed in the path of progress by a minority, the Principal and the staff, together with the School Development Society, the OBA and all its branches, were able to facilitate the construction work speedily.

The Old Boys' Associations of Sri Sumangala College always depends on the advice, guidance and backing of the Principal and values his dedication, strength and courage he displayed linking his hands with the Old Boys' Association when problems arose in establishing the school in the new premises.
